Vendors whose products or practices place them in more than one category are subject to all of the requirements of each category.

Producer: Includes producers of both certified and non-certified agricultural products. Certified products include fresh fruits, nuts, vegetables, shell eggs, honey, nursery stock and cut flowers. Non-certified agricultural products are those that have been processed from the certified producer's certified agricultural products, and can also include livestock and livestock products and poultry and poultry products.
